#### **General Terms and Conditions**

HFN shall, on fulfillment of the Delivery Terms, unless otherwise provided in this Purchase Order, make payment within 30 days of receipt of the Supplier's invoice.

#### 3. LATE DELIVERY

Without limiting any other rights or obligations of the parties hereunder, if the Supplier will be unable to deliver the goods by the delivery date stipulated in this Purchase Order, the Supplier shall immediately consult with HFN to determine the most expeditious means for delivering the goods

#### 4. PROHIBITION ON ADVERTISING

The Supplier shall not advertise or otherwise make public that it is working on a project for HFN without specific permission of HFN in each instance.

# 5. NON-DISCLOSURE AGREEMENT

The supplier shall be required to sign a non-disclosure agreement to ensure that any Confidential Information disclosed to the recipient in connection with the proposed business remains confidential and is not used by the recipient for any purpose other than the proposed business.
